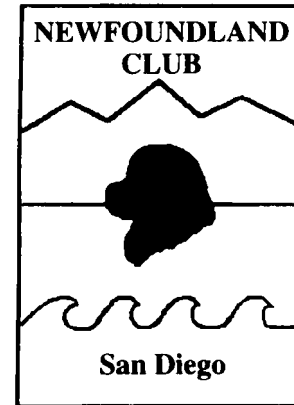

Entry Limitations

Entries close April 2, 2012 at 6:00 pm.

Entries will be accepted starting with a postmark date of March 8, 2012.

Entries will be accepted by mail only.

Entries will be limited to a total of 15 dogs or teams. Entries will close when this number is reached regardless of the closing date. All entries received after the entry limit is filled will be placed on an "alternate list" by order of those without draft titles in order of postmark, followed by re-qualifiers in order of postmark.

All entries will be open only to purebred Newfoundland dogs at least eighteen months of age. All entries must have an AKC registration number, ILP number, foreign registration number or AKC or foreign litter number. A copy must be attached to the entry form.

Re-qualifiers will be accepted on a "space available" basis (untitled dogs will be given first priority).

Bitches in season will be allowed to compete only after all male dogs are judged. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test area.

Test Site

Our test site will be on the grounds of The Green Oak Ranch Ministries. The location is in Vista, CA. and though surrounded by residential and industrial land uses, the grounds are set within a spacious 142-acre rustic site which includes meadows, grassy knolls, ponds and running creeks which are accessed using dirt paths, wood bridges and landscaped paths. The freight haul route will utilize this varied terrain. There will be some up and down grades including natural vegetation and wildlife.
