No generators in use before 6:00 AM or after 10:00 PM. Privileged set up and move in parking on show grounds— Charge \$40.00 for each night. If advanced payment for privileged parking is not paid by February 9, 2011, no guarantee of parking in preferred area can be made. If paid at gate on night before show, charge is \$40.00 per night, with no guarantee parking. **REQUIREMENT** - All units must be self contained, no water. **ELECTRICITY** – Because of rising costs, electricity will be very limited in the three show buildings. 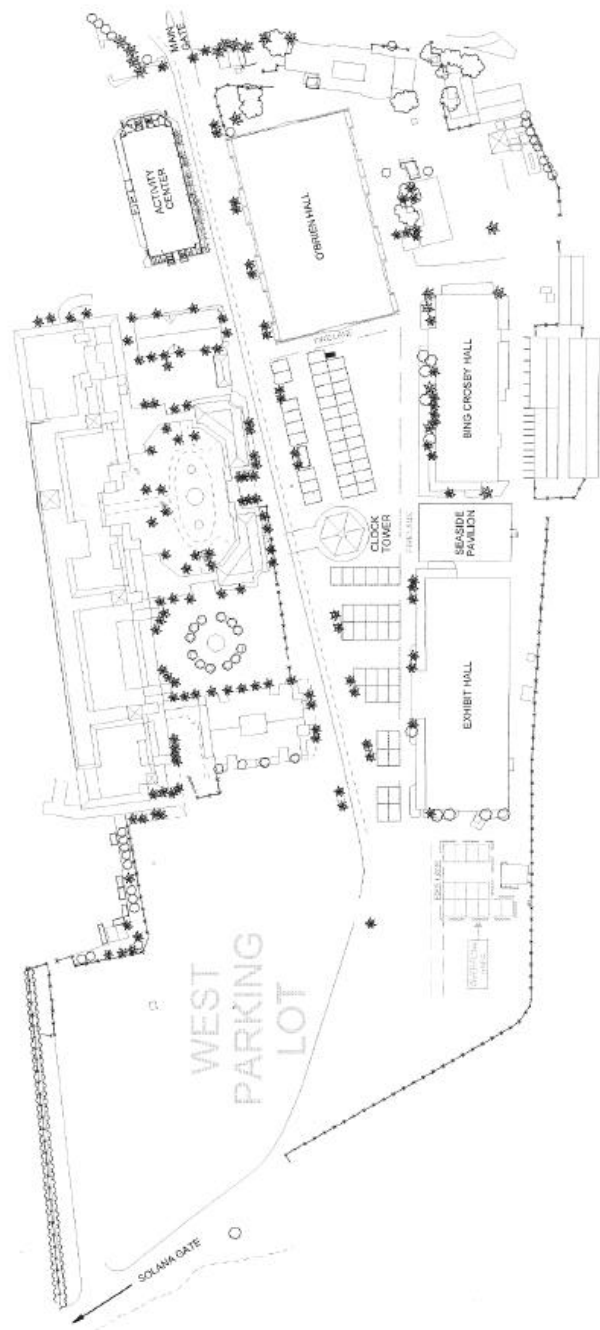

Make All Checks and Money Orders PAYABLE TO LEA PLAUT, CANADIAN exhibitors must make fees payable in U.S. FUNDS. Please mail checks or money orders with entries. Secretary assumes no responsibility for cash sent through the mail. Tabulate carefully. Due to cost of processing no refunds of \$5.00 and under will be made. There is a \$4.00 fee for any entry cancellations.

A Recording Fee of 50¢ per dog and a Service Fee of \$3.00 per entry, \$3.00 Rally fee will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, Rally Trial or Tracking Test. These Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Fees are to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Post Dated Checks, Returned Checks and Declined Credit Cards, do not constitute a valid entry fee. The Secretaries will add a \$25.00 collection fee to the amount of each returned check. The returned check or declined credit card **MUST BE MADE GOOD** by cash or money order **BEFORE** the dog will be allowed in the ring.

No Refund for Duplicate Entries. This club and it's Secretary assume no responsibility for the owner or owner's agents entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.

Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

During the hours of judging owners are to be on call, and have their dogs ready for judging. In order that the judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owners of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. It is not the responsibility of the ring steward, nor of any agent of the show giving club to locate any dog, its owner or handler, when the dogs presence is needed in the judging ring. It should be understood by every exhibitor and handler to bring his dog into the ring.

The club, its secretaries or their employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage, or injury sustained by an exhibitor or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the show grounds.

Cash Prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of that breed is over, and the Secretaries Office advised at once. The Secretaries and show-giving Club disclaim any liability for cash prizes after the judging of the breed is over.

Trophies and Prizes will be awarded in the judging ring before the completion of judging, any discrepancies must be reported to the Secretary prior to completion of judging. All trophies must be claimed the day of the show. None will be mailed.

Dogs which according to their owners records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety Competition, provided this transfer is made by the Secretary at least one half hour prior to the start of the earliest Conformation judging at the Show.

Junior Handlers who win a third Novice Class after the closing of entries may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Secretary at least one half hour prior to the scheduled start of the earliest Conformation judging or one half hour prior to the start of Junior Showmanship judging at the show, whichever is earlier.

Please DO NOT LEAVE ANY DOGS IN CLOSED VEHICLES. Do not leave your dogs in unlocked cars. If any dogs are seen to be suffering from extreme temperatures where it is confined without supervision, a California Humane Officer or a Security Officer will be notified to handle the situation. Violators may be reported to the Show Committee for disciplinary action. all persons attending this show hereby waive any claim for damages against the show giving clubs or their members in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions. **THIS IS A SELF CLEANING SHOW, PLEASE CLEAN UP AFTER YOUR DOGS.**

BEST OF BREED

(No defeated dogs will be allowed to compete)

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

Stud Dog Class: For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

AWARD OF MERIT

After awarding Best of Breed, Best of Winners and Best of Opposite Sex, the judge may award up to a maximum of six (6) Awards of Merit to exhibits in the Breed ring that are, in the judge's opinion, outstanding specimens. The total number of Awards of Merit the judge is allowed to award is determined by the total number of dogs and bitches competing in the Best of Breed competition, as follows: 1 for 7 – 10; up to 2 for 11 – 16; up to 3 for 17 – 23; up to 4 for 24 – 30; up to 5 for 31 – 36; up to 6 for 37 and over.

NOTICE TO ALL EXHIBITORS - Rules Applying to Dog Shows, Effective January 1, 2010

CHAPTER 11, SECTION 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration.

This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

SWEEPSTAKES

Puppy Sweepstakes Rules

Sweepstakes Classes are open to all Newfoundland's over six months and under 18 months. Dogs must also be entered in a regular class. Sweepstakes Classes will be judged prior to the Regular Classes.

Puppy Sweepstakes Classes To be divided by sex:

- 6 months and under 9 months
- 9 months and under 12 months
- 12 months and under 15 months
- 15 months and under 18 months

Veteran Sweepstakes Rules

Veteran Sweepstakes are open to all Newfoundland's 7 years of age and older. Dogs need not also be entered in a regular class.

Veteran Sweepstakes Classes To be divided by sex:

- 7 years and under 9 years
- 9 years and over

Sweepstakes Prizes

The Club will retain 35% of the Sweepstakes fee for expenses.

The remainder will be divided among the class winners as follows:

- Classes of 4 or more entries: 1st – 40%, 2nd – 30%, 3rd – 20%, 4th – 10%
- Classes of 3 entries: 1st – 50%, 2nd – 30%, 3rd – 20%
- Classes of 2 entries: 1st – 60%, 2nd – 40%
- Classes with 1 entry: 1st – 100%

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.
