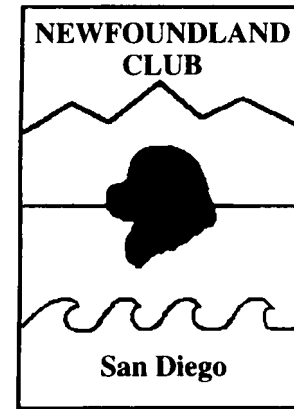

## Entry Limitations

Entries close Feb. 28, 2010 at 6:00 pm.

Entries will be accepted starting with a postmark date of Jan. 25, 2010.

Entries will be accepted by mail only.

Entries will be limited to a total of 10 dogs or teams. Entries will close when this number is reached regardless of the closing date. All entries received after the entry limit is filled will be placed on an "alternate list" by order of those without draft titles in order of postmark, followed by re-qualifiers in order of postmark.

All entries will be open only to purebred Newfoundland dogs at least eighteen months of age. All entries must have an AKC registration number, ILP number, foreign registration number or AKC or foreign litter number. A copy must be attached to the entry form.

Re-qualifiers will be accepted on a "space available" basis (untitled dogs will be given first priority).

Bitches in season will be allowed to compete only after all male dogs are judged. When not being tested, bitches in season must be contained in a designated area well away from male dogs and the official test area.

## Test Site

Our test site will be the training grounds and surrounding areas of Kindred Spirits Dog Training and Education Center. The setting is located in Vista, CA. The site is in established equestrian country with large grassy knolls and a dirt path along a pond. The freight haul route will utilize this varied terrain which includes meadows, trails through the trees and country roads into an established residential area. There are steep up-and-down grades.

The site is available on Saturday March 13, 2010 for informal practice in the afternoon. Times to be announced..

*All dogs are required to be restrained in a crate or on leash except while being judged. **ONLY ENTERED DOGS WILL BE ALLOWED IN THE TEST AREA. NO EXCEPTIONS !!!***
